**FOR THREE YEAR OLDS AND UPWARD** No nomination fee. \$500 to pass the entry box and an additional \$500 to start. Supplemental nominations may be made at time of entry for \$1,500 and shall include all fees. After payment of 1.5% of the purse to all owners finishing sixth through last, 60% of the remaining purse shall be paid to the winning owner, 20% to second, 11% to third, 6% to fourth, and 3% to fifth. If less than five horses start, the remaining purse will be distributed to the winning owner. Starters to be named through the entry box by the usual time of closing. Weights: Three Year Old, 121 lbs. Older, 124 lbs. Non-winners of \$25,000 in 2024 allowed 2 lbs.; Non-winners of \$15,000 since November 27, 2023 allowed 4 lbs.; Non-winners of \$15,000 in 2023-2024 allowed 6 lbs. Maiden and claiming races not considered in weight allowances. Total earnings in 2023-2024, as determined by the information provided by Equibase Company, will be used in determining the order of preference. The field will be limited to fourteen starters. Horses not drawing a starting position in the gate will receive a refund of the entry of the entry fee. A trophy will be presented to the winning owner.
