FOR ACCREDITED TEXAS-BRED, FILLIES AND MARES, THREE YEAR OLDS AND UPWARD No nomination fee. \$375 to pass the entry box and an additional \$375 to start. Supplemental nominations may be made at time of entry for \$1,125 and shall include all fees. After payment of 1.5% of the purse to all owners finishing sixth through last, 60% of the remaining purse shall be paid to the winning owner, 20% to second, 11% to third, 6% to fourth, and 3% to fifth. If less than five horses start, the remaining purse will be distributed to the winning owner. Starters to be named through the entry box by the usual time of closing. Weights: Three Year Olds, 120 lbs. Older, 123 lbs. Non-winners of \$20,000 in 2024 allowed 2 lbs.; Non-winners of \$15,000 in 2024 allowed 4 lbs.; Non-winners of \$10,000 since January 13, 2024 allowed 6 lbs. Maiden and claiming races not considered in allowances. Total earnings in 2023-2024 as determined by the information provided by Equibase Company, will be used in determining the order of preference of horses assigned equal weights. The field will be limited to twelve starters. Horses not drawing a starting position in the gate will receive a refund of the entry fee. A trophy will be presented to the winning owner.
