FOR ARABIAN THREE YEAR OLDS AND UPWARD No nomination fee. \$500 to enter and an additional \$500 to start with \$60,000 Added. Supplemental Nomination payment of \$2,000 is due at the time of entry and includes all fees. The Added monies and all fees to be divided 60% to the owner of the winner, 20% to second, 10% to third, 6% to fourth, and 4% to fifth after sixth thru tenth are paid \$3,500 each. If less than ten horses start, the purse monies not awarded will revert to the winning owner. Weights: Three Year Olds, 122 lbs.; Older, 124 lbs. Non-winners of two races in 2024 allowed 2 lbs.; a race in 2024, 4 lbs. (Claiming races not considered in allowances). Starters to be named through the entry box by the usual time of closing. Preference given to original nominations with the highest earnings in 2023-2024. The field will be limited to twelve starters. Horses not drawing a starting position in the gate will receive a refund of their entry fee. A trophy will be presented to the winning owner.
